At its meeting held today, the Board of Directors of ArthaLand Corporation (the "Corporation") approved the declaration of cash dividends to holders of <u>Preferred Shares Series B</u> with record date of <u>16 August 2018</u> in the amount of <u>P1.76145</u> per preferred share, or a total of <u>P35,229,000.00</u>, which will be paid out beginning <u>06 September 2018</u> from the company's unrestricted retained earnings as of 30 June 2018.
