#### Item 9. Other Events

On 07 June 2017, it was disclosed that **ArthaLand Corporation (the "Corporation")** obtained a loan from Signature Office Property, Inc. (the "Lender")<sup>1</sup> in the amount of P207,051,912.00 with a maturity date on 31 December 2018. This loan is interest free and payable in cash or in kind at the option of the Lender. In the event the Lender elects to be paid in kind, the Corporation shall pay the loan *via dacion en pago* with the net saleable area of the 28<sup>th</sup> floor of ArthaLand Century Pacific Tower, a commercial building developed by the Corporation in Bonifacio Global City, Taguig City, and 10 parking slots therein, at the total purchase price of P207,051,912.00, inclusive of value added tax.

The Corporation received notice from the Lender that it has elected to be paid in kind. Management will now take the necessary steps to implement the transaction accordingly.
