Item 4. Resignation, Removal or Election of Registrant's Directors or Officers

In its recently concluded meeting, the Board of Directors of **Arthaland Corporation** (the "Corporation") approved the appointment of Engineers Alex D. Miguel and Richard Naval both as Vice President of the Technical Services Group, after the Governance and Nomination Committee vetted their respective qualifications.

Mr. Miguel is a graduate of the Holy Angel University in Angeles City, Pampanga, with a Bachelor of Science degree in Civil Engineering. He has more than 36 years of work experience in Construction Management specifically estate development and residential and commercial construction for vertical and horizontal projects. He worked previously with D.M. Consunji, Inc., Makati Development Corporation, Alveo Land Corporation, Taft Property Ventures & Development Corporation, Federal Land Incorporated, and most recently, Shang Properties, Inc.

Mr. Naval, on the other hand, is a graduate of Civil Engineering from the University of Santo Tomas and has some units on Masters in Construction Management from the Polytechnic University of the Philippines Open University. He has more than 20 years experience in construction and project management in a leadership capacity. He worked previously in Filinvest Land, HongKong Land, Geo Estate Development Corporation, Costa Del Hamilo, Robinsons Land Corporation and Federal Land.

Mr. Miguel will oversee and be primarily responsible for the construction of Sevina Park, initially, and for other projects that will be subsequently assigned to him. Mr. Naval will be assigned to manage some of the ongoing and subsequently, upcoming, high-rise projects of the Corporation. Their main role is to ensure that the Corporation delivers quality expected for its projects in a timely manner.

Messrs. Miguel and Raval do not own shares of stock of the Corporation.
