The Board of Directors of **Arthaland Corporation (the “Corporation”)** approved on 15 December 2021 the purchased and acquisition by way of secondary sale all of the rights, title and interest of Rock and Salt B.V. (the “Company”) in and to 40% of the issued and outstanding shares of stock of Cebu Lavana Land Corp. (**CLLC**), or 214,351 common shares of stock and 118,982 preferred shares of stock thereof, for and in consideration of the amount of ₱113,159,210.00, on the condition that the parties agree to the terms and conditions outlined in the definitive agreement provided by the Corporation.

The Corporation also purchased and acquired by way of secondary sale all of the rights, title and interest of the Company in and to its shareholder advances in CLLC and all of the interest accrued on such principal amount of shareholder advances, for and in consideration of the amount of ₱762,340,790.00, likewise under the condition that the parties agree to the terms and conditions outlined in the definitive agreement provided by the Corporation.

The Corporation and the Company signed and executed the Share Purchase Agreement today.

With the foregoing, the Corporation will own 100% of CLLC.
